Guest Speaker

Mrs Josephine Stone AM

Mrs Josephine Stone AM was appointed to Australian War Memorial Council on 26 February 2015. Mrs Stone is a graduate of the Melbourne Law School and has worked in a number of legal institutions, both public and private, in Victoria and the Northern Territory of Australia. Previous professional involvements include being a statutory member of the Regional Telecommunications Independent Review Committee (CWRH), Professional Standards Manager at the Northern Territory Law Society, Assignments Director at the Northern Territory Legal Aid Commission, solicitor with the Australian Government, Solicitor and with private firms in Melbourne, Alice Springs and Darwin. Currently, Mrs Stone is a director of a private family company. Community engagements include Zonta Alice Springs, Darwin Private Hospital Advisory Board, NT Women's Advisory Board, Chairman of the Red Cross (Katherine) Flood Appeal, together with a number of roles in school Parents and Friends committees and boards in Darwin and Brisbane. Additional personal interests have included instigating the 100 year history of St Mary's Primary School in Darwin and the political advancement of women, which has involved a number of appearances at international conferences as moderator and speaker. Mrs Stone was made a Member of the Order of Australia in 2006 for services to the Law and the community.
